Re: General Construction Worker
Under the Master Labor Agreement-
Allocation of Increase Effective July 1, 2011

The General Construction Worker classification for private work only includes the following classifications of work: Cleaning of Forms, Fire Watcher, Flagman, General Cleanup, Root Picker, Soft Demolition—cleaning of brick, lumber and all hand work, Setting of Forms, Tool Crib, Torchman on Steel Salvage, Toxic Waste Remover Helper, Watchman and Window Cleaner.

Effective July 1, 2011, the following hourly rates apply:

*Includes supplemental dues of \$0.49.

No employee who has previously worked under the Master Labor Agreement or a predecessor Agreement shall be employed in the General Construction Worker classification unless the employee voluntarily accepts such position. It is understood and agreed that any such employee must be redispached prior to working in the General Construction Worker classification.
